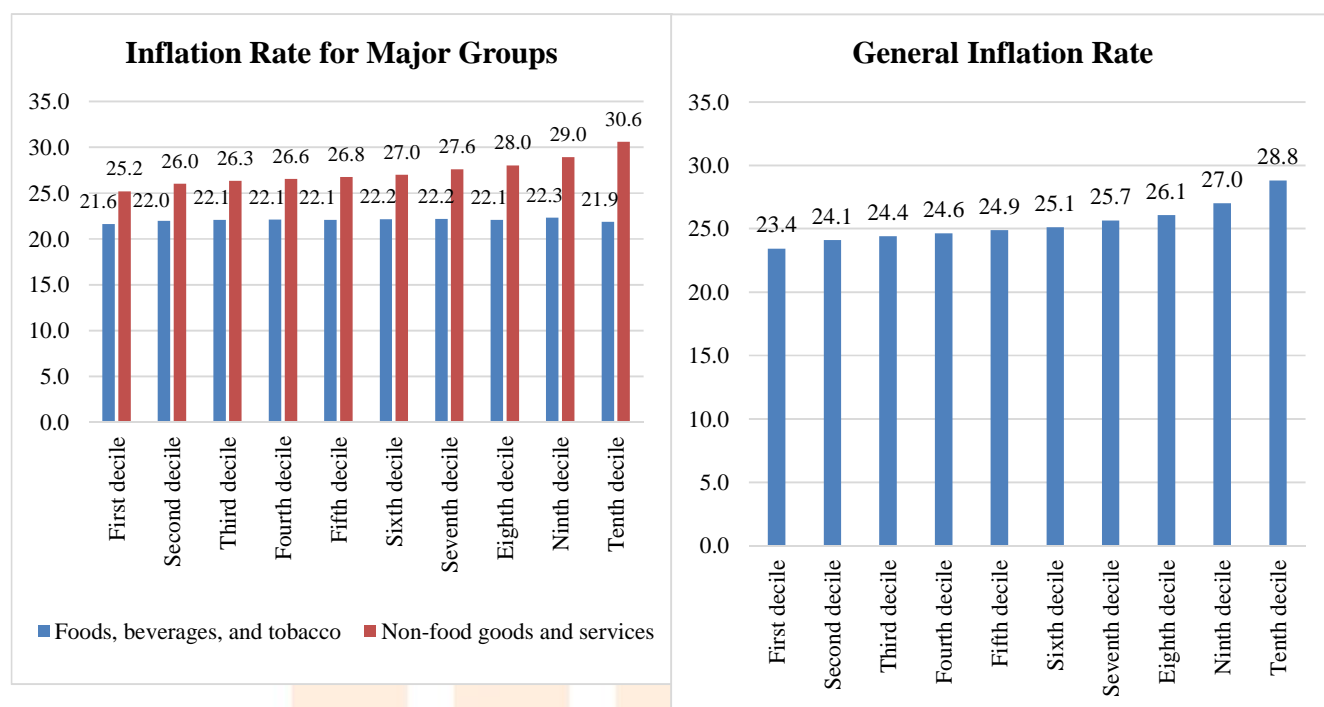


National Consumer Price Index by Expenditure Deciles in the Month of Mordad¹ of the year 1399²

The national inflation rate for the month of Mordad of the year 1399 stood at 25.8 percent, fluctuating between 23.4 percent for the first decile (those with the lowest income) and 28.8 percent for the tenth decile (those with the highest income) among the expenditure deciles. The range of the twelve-month inflation changes in the major group of "food, beverages and tobacco" was between 21.6 percent for the first decile and 22.3 percent for the tenth decile. The major group of "non-food items and services" also saw these fluctuations ranging from 25.2 percent for the first decile to 30.6 percent for the tenth decile³.

Inflationary gap of deciles

According to the inflation rates for the expenditure deciles, the deciles inflationary gap in this month stood at 5.4 percent showing a 0.7 percentage point rise compared with the previous month (4.7 percent). The inflationary gap in the major groups of "food, beverages and tobacco" and non-food items and services" decreased by 0.9 and increased by 0.8 percentage points in contrast to the previous month, respectively.

Point- to- point inflation of deciles or change in the national households purchasing power compared with the corresponding month in the previous year is shown in the following table.
