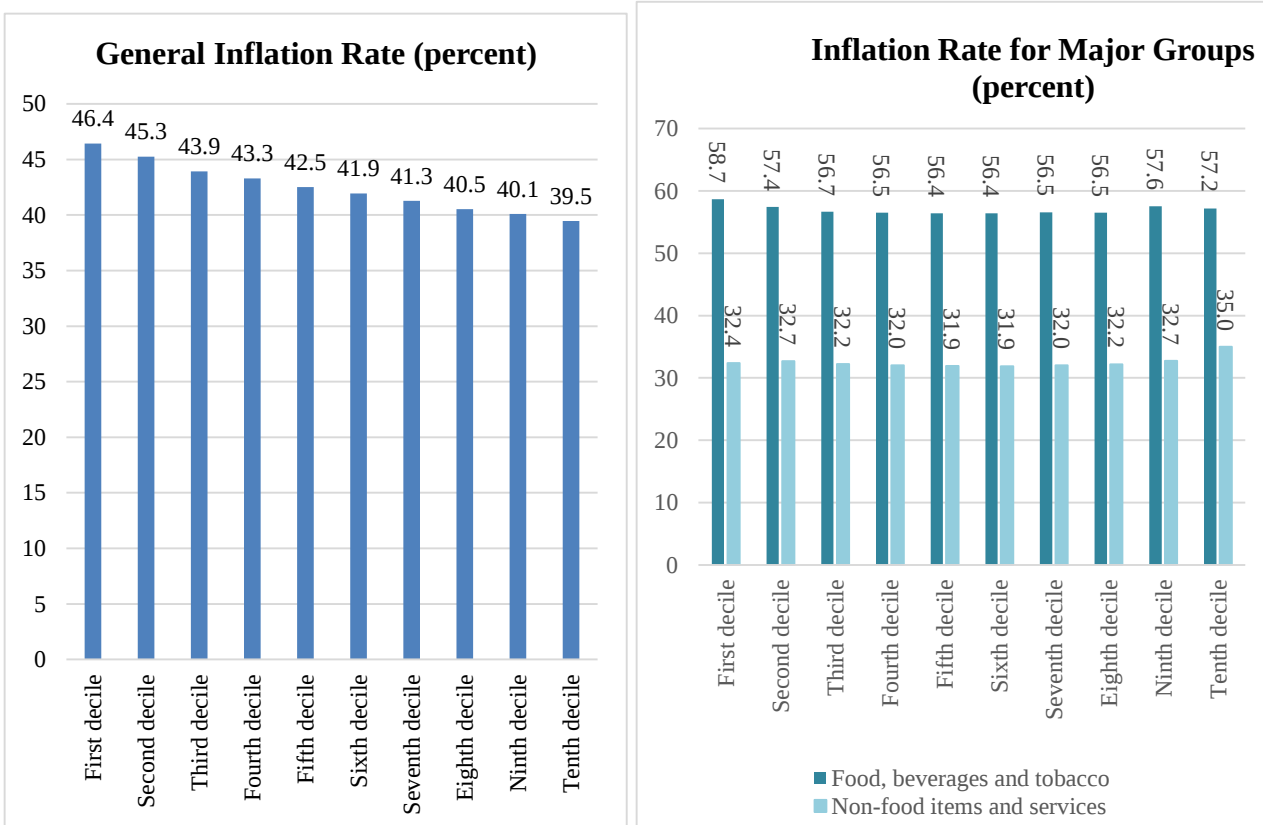


National Consumer Price Index by Expenditure Deciles in the Month of Mordad¹ of the year 1401²

The national inflation rate for the month of Mordad of the year 1401 stood at 41.5 percent, fluctuating between 39.5 percent for the tenth decile (those with the highest income) and 46.4 percent for the first decile (those with the lowest income) among the expenditure deciles. The range of the twelve-month inflation changes in the major group of “food, beverages and tobacco” was between 56.4 percent for the fifth and sixth deciles and 58.7 percent for the first decile. The major group of “non-food items and services” also saw these fluctuations ranging from 31.9 percent for the fifth and sixth deciles to 35.0 percent for the tenth decile³.

2. It is the Iranian Year which usually begins on the day of 21 March of Gregorian calendar. To find the corresponding year of Gregorian calendar, add 621 or 622 (depending on the time of the year) to a solar Hijri year. For example, the corresponding year of the year 1401 in Gregorian calendar is (21 March 2022-20 March 2023).

Inflationary gap of deciles

According to the inflation rates for the expenditure deciles, the decile inflationary gap in this month (Mordad, the year 1401) stood at 7.0 percentage points which has increased by 1.2 percentage points compared with the previous month (5.8 percentage points). The inflationary gap in the major group of “food, beverages and tobacco” increased by 0.5 percentage points but in the major group of “non-food items and services”, the inflationary gap experienced 0.1 percent fall compared to the previous month.

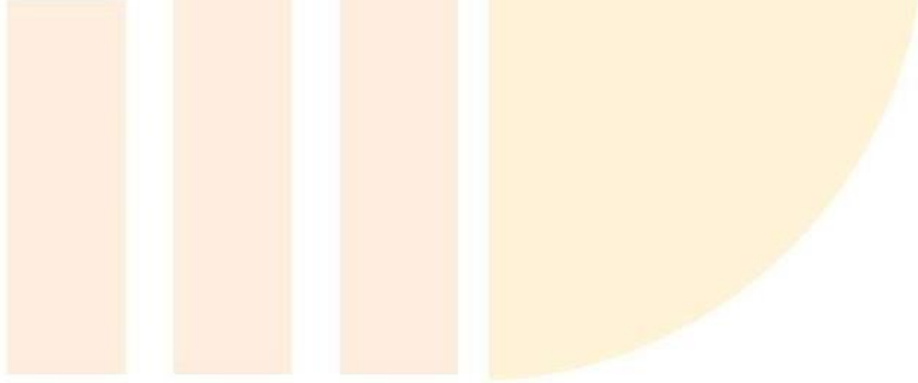
