


National Consumer Price Index by Expenditure Deciles in the Month of Azar¹ of the year 1399²

The national inflation rate for the month of Azar of the year 1399 stood at 30.5 percent, fluctuating between 27.9 percent for the first decile (those with the lowest income) and 37.2 percent for the tenth decile (those with the highest income) among the expenditure deciles. The range of the twelve-month inflation changes in the major group of "food, beverages and tobacco" was between 25.6 percent for the tenth decile and 29.5 percent for the second decile. The major group of "non-food items and services" also saw these fluctuations, ranging from 26.3 percent for the first decile to 40.3 percent for the tenth decile³.

Inflationary gap of Deciles


According to the inflation rates for the expenditure deciles, the decile inflationary gap in this month stood at 9.3 percent showing a 0.4 percentage points rise compared with the previous month (8.9 percent). The inflationary gap in the major groups of "food, beverages and tobacco" and "non-food items and services" increased by 0.4 and 1.5 percentage points in contrast to the previous month, respectively.

Point-to-point inflation of deciles or change in the national households purchasing power compared with the corresponding month in the previous year is shown in the following table.


