


## National Consumer Price Index by Expenditure Deciles: in the Month of Khordad<sup>1</sup> of the year 1399<sup>2</sup>

The national inflation rate for the month of Khordad of the year 1399 stood at 27.8 percent, fluctuating between 25.8 percent for the first decile (those with the lowest income) and 30.0 percent for the tenth decile (those with the highest income) among the expenditure deciles. The range of the twelve-month inflation changes in the major group of "food, beverages and tobacco" was between 25.4 percent for the first decile and 27.9 percent for the tenth decile. The major group of "non-food items and services" also saw these fluctuations ranging from 26.1 percent for the first decile to 30.5 percent for the tenth decile<sup>3</sup>.

## Inflationary gap of deciles

According to the inflation rates for the expenditure deciles, the deciles inflationary gap in this month stood at 4.2 percent showing a 0.3 percentage point rise compared with the previous month (3.9 percent). The inflationary gap in the major groups of "food, beverages and tobacco" and non-food items and services" decreased by 0.8 and 0.4 percentage points in contrast to the previous month, respectively.


