


National Consumer Price Index by Expenditure Deciles: in the Month of Tir¹ of the year 1399²

The national inflation rate for the month of Tir of the year 1399 stood at 26.4 percent, fluctuating between 24.2 percent for the first decile (those with the lowest income) and 28.9 percent for the tenth decile (those with the highest income) among the expenditure deciles. The range of the twelve-month inflation changes in the major group of "food, beverages and tobacco" was between 22.9 percent for the first decile and 24.4 percent for the tenth decile. The major group of "non-food items and services" also saw these fluctuations ranging from 25.5 percent for the first decile to 30.1 percent for the tenth decile³.

Inflationary gap of deciles

According to the inflation rates for the expenditure deciles, the deciles inflationary gap in this month stood at 4.7 percent showing a 0.5 percentage point rise compared with the previous month (4.2 percent). The inflationary gap in the major groups of "food, beverages and tobacco" decreased by 0.9 percentage points but increased by 0.1 percentage points in the major groups of "non-food items and services" in contrast to the previous month, respectively.

Point- to- point inflation of deciles or change in the national households purchasing power compared with the corresponding month in the previous year is shown in the following table.



Monthly Percentage Change in General Price Index for Goods and Services Consumed by National Households Disaggregated by Expenditure Deciles




