

Consumer Price Index for the Month of Mordad¹, the Year 1403 (Base year 1400=100)


Price Index

In the month of Mordad, the year 1403, the national Consumer Price Index (CPI) for households was 260.2, showing a 2.0 percent increase from the previous month. It experienced a growth of 31.6 percent compared to the same month of the previous year, and a rise of 34.8 percent in the 12 months ending the month of Mordad, the year 1403 compared to the last corresponding period.

National Point-to-point Inflation Rate

The point-to-point inflation rate is defined as the percentage change in the price index compared to the corresponding month of the previous year. In the month of Mordad of the year 1403, the point-to-point inflation rate was 31.6 percent. This indicates that national households spent, on average, 31.6 percent more on purchasing the “same goods and services” compared to the month of Mordad in the year 1402. Furthermore, the point-to-point inflation rate decreased by 0.6 percentage points compared to the previous month (Tir, the year 1403).



To find the corresponding year of Gregorian calendar, add 621 or 622 (depending on the time of the year) to a solar Hijri year. For example, the corresponding year of the year 1403 in Gregorian calendar is (21 March 2024-20 March 2025).

The National Monthly Households Inflation Rate

The monthly inflation rate is the percentage change in the price index compared to the previous month. In the month of Mordad of the year 1403, the monthly inflation rate was 2.0 percent. The monthly inflation rates for the major groups of “food, beverages, and tobacco” and “non-food items and services” were 1.1 and 2.4 percent, respectively. Below, you will find the monthly inflation rates of various groups for the current month.

The Monthly National Inflation Rate for Goods and Services, the Month of Mordad, the Year 1403 (percent)




The National Annual Households Inflation Rate


The annual inflation rate means the average percentage change in the price index in the year ending the current month compared to the same period in the previous year. The annual national household inflation rate for the month of Mordad of the year 1403 stood at 34.8 percent, which decreased by 0.7 percentage points in comparison with the previous month (Tir, the year 1403).

The Annual Inflation Rate for Goods and Services Consumed by National Households by Ostan, the Month of Mordad, the Year 1403 (percent)




The time series of national inflation and point-to-point inflation rates for goods and services during the recent years are shown in the following chart.

The national inflation rate for the month of Mordad of the year 1403 stood at 34.8 percent, fluctuating between 31.1 percent for the first decile (those with the lowest income) and 35.6 percent for the tenth decile (those with the highest income) among the expenditure deciles. Accordingly, the inflationary gap among the deciles was 4.5 percentage points, which experienced a 0.3 percentage point decrease compared to the previous month (Tir, the year 1403) (4.8 percentage points).

The following chart shows the monthly and point-to-point inflation rates for expenditure deciles in the month of Mordad of the year 1403.


