

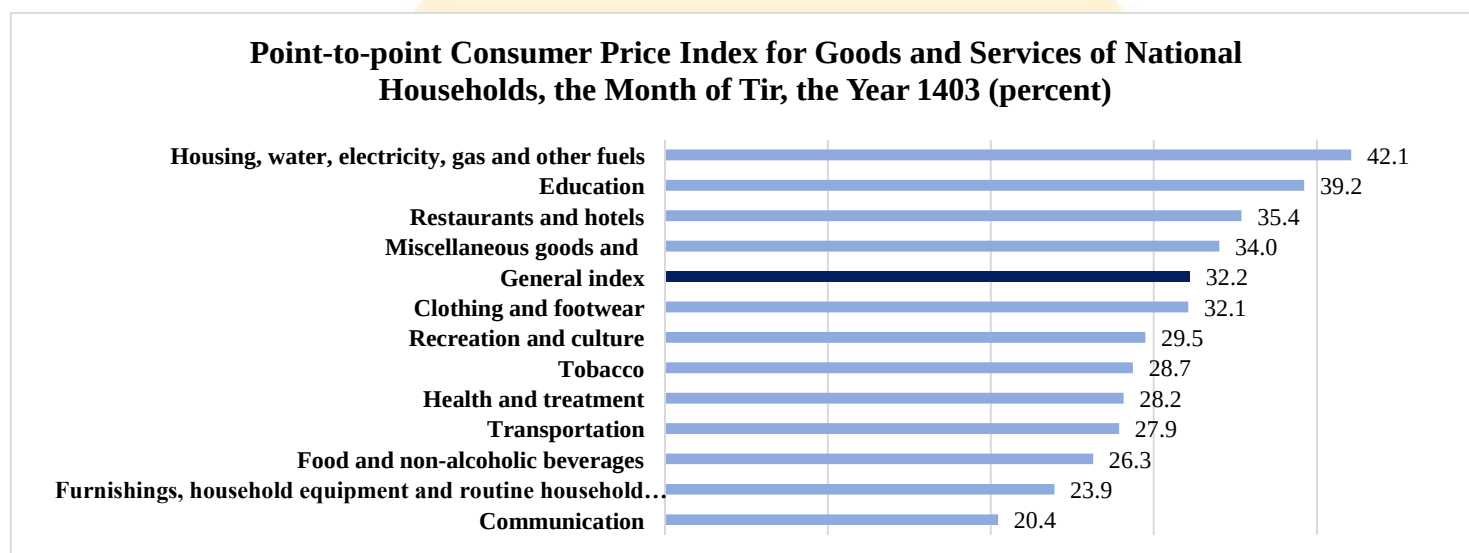
Consumer Price Index for the Month of Tir¹, the Year 1403 (Base year 1400=100)

Price Index

In the month of Tir, the year 1403, the national Consumer Price Index (CPI) for households was 255.2, showing a 2.2 percent increase from the previous month. It experienced a growth of 32.2 percent compared to the same month of the previous year, and a rise of 35.5 percent in the 12 months ending the month of Tir, the year 1403 when compared to the last corresponding period.

National Point-to-point Inflation Rate

The point-to-point inflation rate is defined as the percentage change in the price index compared to the corresponding month of the previous year. In the month of Tir of the year 1403, the point-to-point inflation rate was 32.2 percent. This indicates that national households spent, on average, 32.2 percent more on purchasing the “same goods and services” compared to the month of Tir in the year 1402. Furthermore, the point-to-point inflation rate increased by 0.3 percentage points compared to the previous month (Khordad, the year 1403).



The National Monthly Households Inflation Rate

The monthly inflation rate is the percentage change in the price index compared to the previous month. In the month of Tir of the year 1403, the monthly inflation rate was 2.2 percent. The monthly inflation rates for the

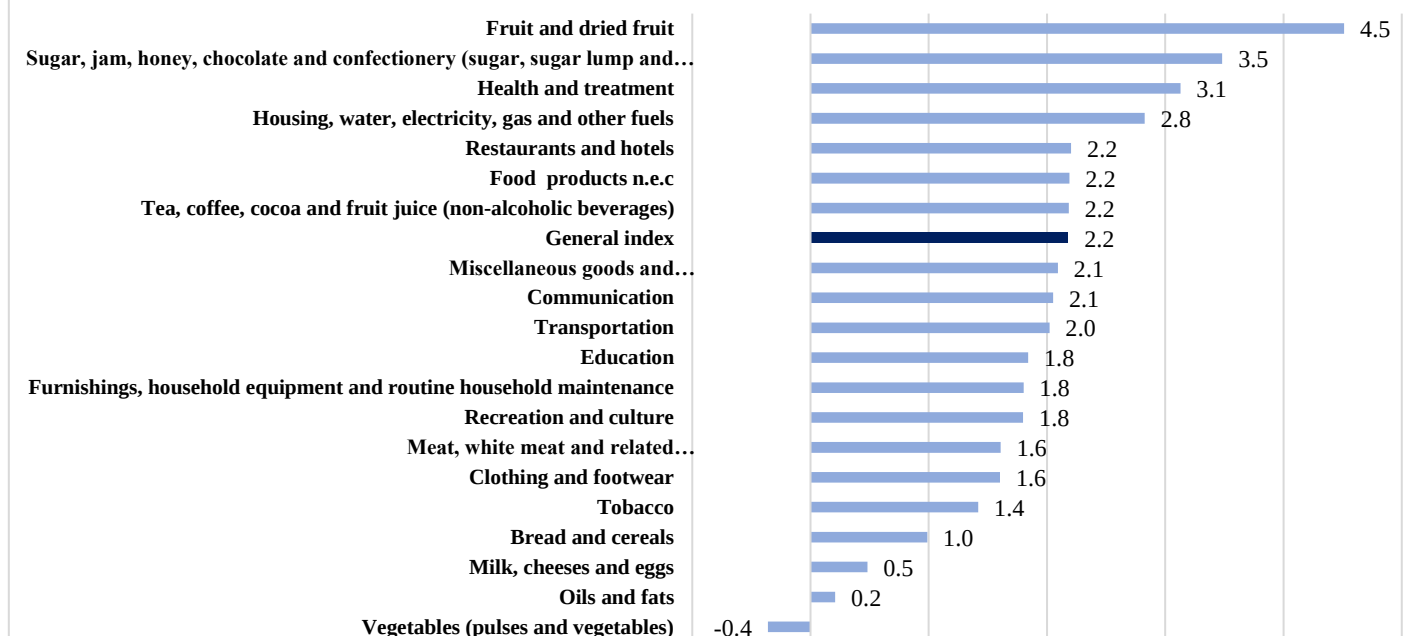

The National Annual Households Inflation Rate

The annual inflation rate means the average percentage change in the price index in the year ending the current month compared to the same period in the previous year. The annual national household inflation rate for the month of Tir of the year 1403 stood at 35.5 percent, which decreased by 0.6 percentage points in comparison with the previous month (Khordad, the year 1403).

The Annual Inflation Rate for Goods and Services Consumed by National Households by Ostan, the Month of Tir, the Year 1403 (percent)

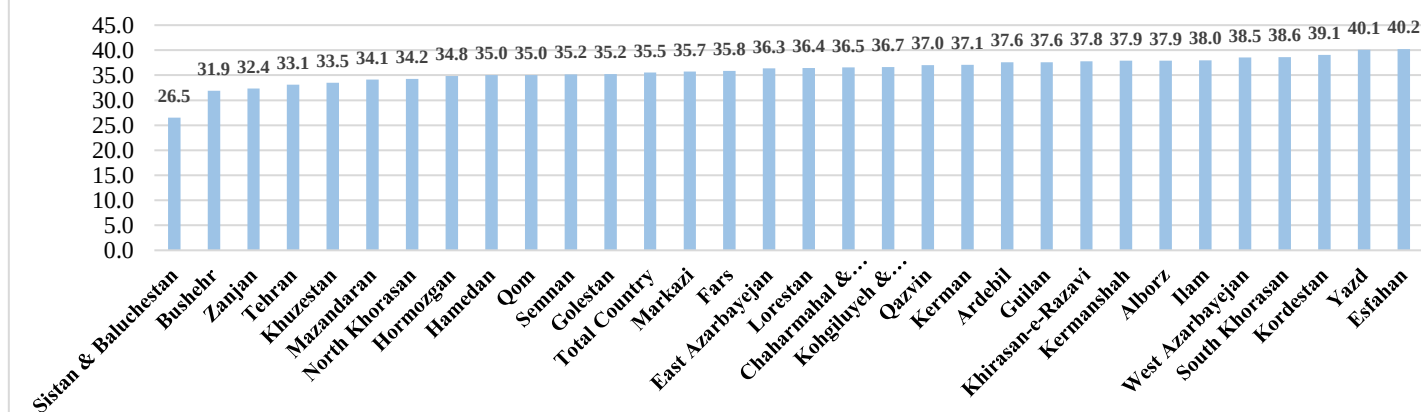

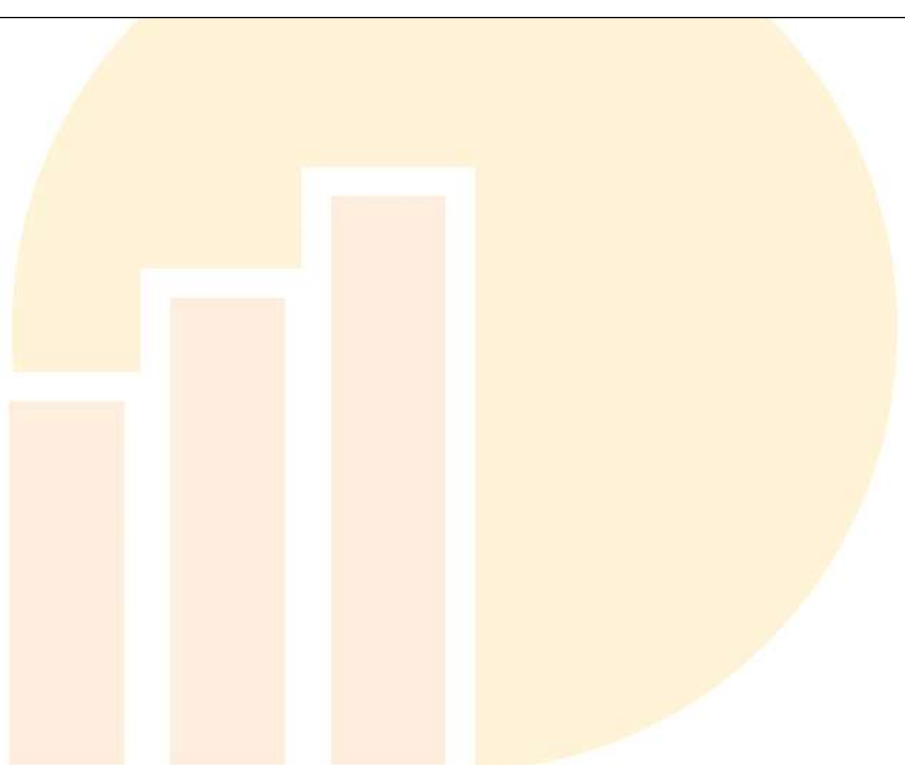
