

### *Introduction*

**T**he household expenditure and income (household budget) were first studied in the year 1314 by the National Bank of Iran. The main objective of the study was to obtain the consumption coefficients for calculation of living expenditure index.

After a long cease, in the year 1338, the Economic Studies Office of the National Bank of Iran collected statistics in this field by interviewing sample households in 23 cities of the country to revise the weight of the living expenditure index. The Central Bank of the I.R. Iran has regularly conducted some studies on the income and expenditure of urban households since the year 1344. Since the year 1347, the survey of household expenditure in urban areas, on a larger scale, was initiated by the Statistical Centre of Iran (SCI).

Since the year 1353, the survey has covered both expenditure and income of urban households and continued to date, excluding the years 1355, 1357 and 1360. The results have been processed and published annually.

Survey of rural households expenditure and income was first conducted by the General Department of Public Statistics in the year 1342, and by the establishment of the SCI in the year 1344, the survey continued on a larger scale by the new organization.

Currently, statistics on urban households expenditure and income are released by both the Central Bank and the SCI; however, those on rural households are released by the SCI.

In this chapter, the statistics on average annual food and non-food expenditures of an urban and a rural household have been presented by deciles of

expenditure, size of household, and average annual income of the mentioned households by income sources based on the results of the SCI's (sample) surveys. These surveys were taken according to the United Nations recommendations (NHSCP and SNA publications). The sample survey is conducted by visiting sample households in urban and rural areas.

### *Definitions and concepts*

***Household consumption expenditure:*** rial value of goods and services provided by the household for own consumption or as gifts to others via purchase, household production, against service, trading and free receipts (from organizations).

***Household gross expenditure:*** household expenditure regardless of the rial value from the sale of second-hand goods.

***Net expenditure:*** gross expenditure less the sale of second-hand goods. Where the value of the sold goods is more than the purchased goods, the result is published as a negative figure

***Household, urban and rural areas:*** see Chapter 3, "Population" Definitions and concepts.

***Decile:*** expenditure of the consuming population sorted on the basis of the goods and services charges and then dividing the society into ten equal groups. Each group is called a decile

***Household income:*** refers to all the sums and rial value of goods and services received by the household members for the job done or capital invested or from other resources (retirement pension, assets income, transitional receipts, etc.). In this survey, various net incomes are as follows:

***Net wage and salary income of public, cooperative and private sectors:*** refers to the income of all the wage and salary earners of the household working in public, cooperative and

private sectors including their continuous and non-continuous monetary and non-monetary receipts after deduction of the tax and retirement allowance.

**Agricultural self-employment income:** refers to the income of the members of the household as an employer or own account worker in the agricultural sector after deduction of job on costs. The job on costs covers paid wage and salary, primary material charges, non-durable appliances, amortization, other production charges, and job taxes.

**Non-agricultural self-employment income:** refers to the income of the members of the household as an employer or own account worker in the non-agricultural self-employment sector, after deduction of job on costs.

**Miscellaneous income:** refers to all sums and goods value the household has received through ways other than its members' employment, such as selling of the home-made manufactures, retirement pension, rental of movable and immovable assets, dividend, and charity and social security organization aids.

#### ***Selected information***

In the year 1397, the average annual net expenditure of an urban household amounted to 393.2 million rials including 298.7 million rials for non-food expenditures (76 percent) and 94.5 million rials (24 percent) for food and tobacco expenditures which increased by 19.3 percent in comparison with the previous year.

In the year 1397, out of 298.7 million rials for average annual urban household net non-food expenditure, the highest and lowest share was related to housing expenditure with 133.4 million rials (44.6 percent) and recreation, entertainment and cultural services with 10.7 million rials (3.6 percent), respectively.

Furthermore, in the same year, out of 94.5 million rials for annual urban household food and tobacco expenditures, the highest and lowest share was related to meat with 19.7 million rials (20.8 percent) and oils and fats with 3.1 million rials (3.3 percent), respectively.

In the year 1397, average annual rural household net expenditure amounted to 214.5 million rials including 134.2 million rials for non-food expenditures (62.6 percent) and 80.2 million rials (37.4 percent) for food and tobacco expenditures which increased by 20.0 percent in comparison with the previous year.

In the year 1397, out of 134.2 million rials for the average net non-food expenditure of a rural household, housing expenditure with 37.5 million rials (27.9 percent) and recreation, entertainment, and cultural services expenditure with 3.8 million rials (2.8 percent) accounted for the highest and lowest proportion of expenditure, respectively. Moreover, out of 80.2 million rials, average net food and tobacco expenditure of a rural household, cereals and cereal products with 19 million rials (23.7 percent) and spices, seasonings and pickles with 3.2 million rials (4 percent) had the highest and the lowest shares among the expenditure items, respectively.

In the year 1397, the average annual income of an urban household was about 434.9 million rials. Out of the income sources, miscellaneous incomes with 216.1 million rials (49.7 percent) were of the highest share.

Also in the year 1397, the average annual income of a rural household amounted to 233.1 million rials. Out of the income sources, miscellaneous incomes with 87.2 million rials (37.4 percent) were of the highest share

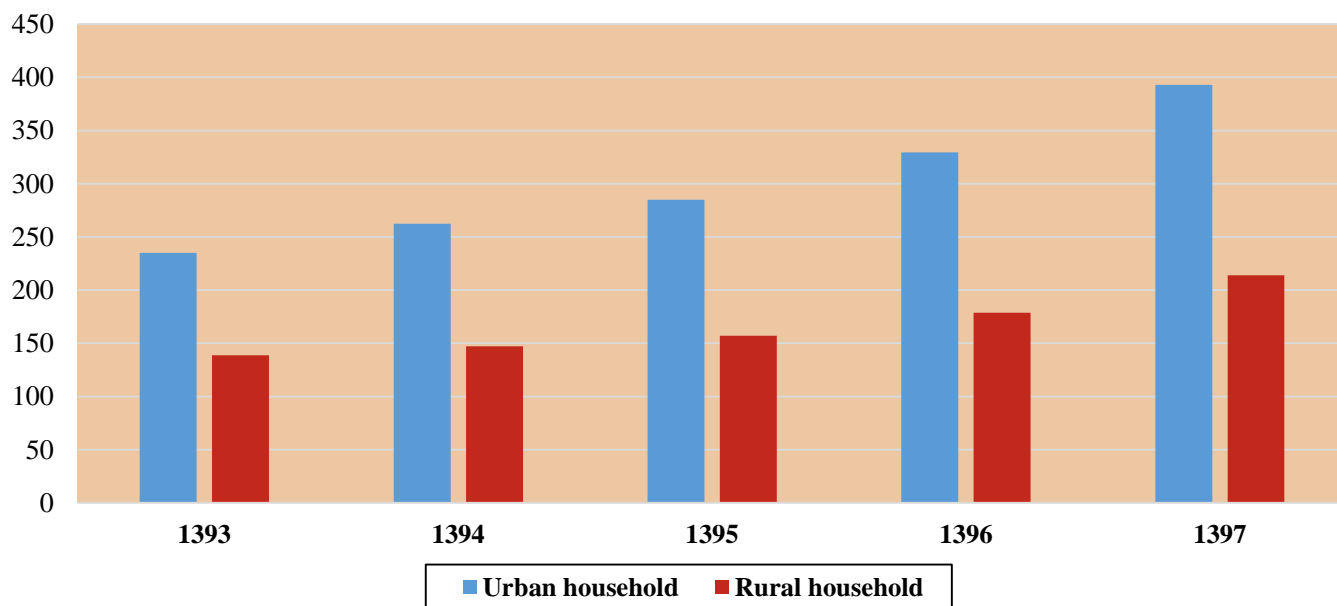

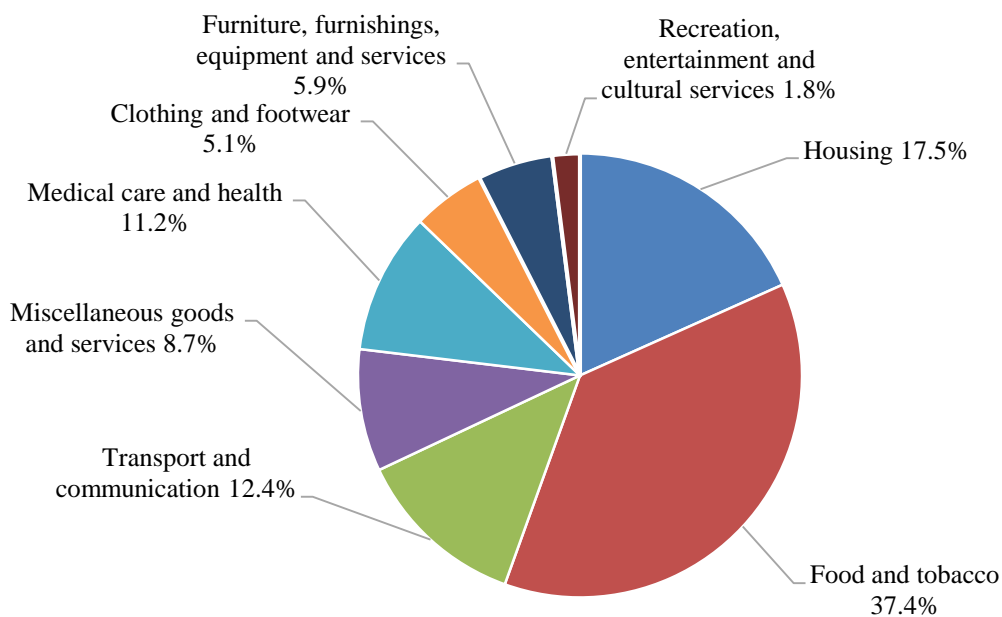

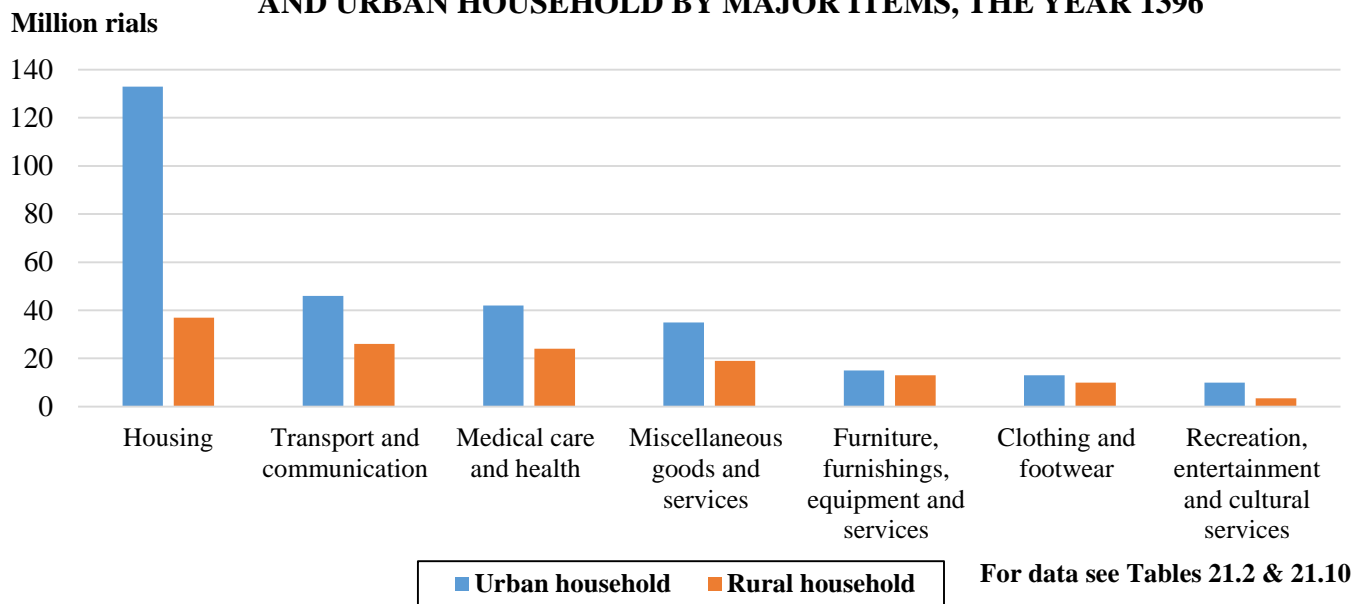
